Second Dog Policy: There is no second dog set-up. Each dog must have their own handler for each odor.

Entry Method

Online entry preferred via Google Form and PayPal Link. USPS Mail accepted and confirmed upon receipt without signature required.

Notification

Acknowledgement of entry acceptance/confirmation, will be made by email when entries are processed for those handlers that provide an email address.

Entry Requirements

A Qualified Entry is one that meets <u>all</u> the following criteria:

- 1. Complete entry during the specified entry time frame.
- 2. The Handler is a NACSW member for the 2023-2024 membership year (8/1/23-7/31/24).
- 3. The Dog is registered with the NACSW.
- 4. Dogs participating in an Odor Recognition Test (ORT) must be at least six months of age.

For Exhibit Only Dogs (FEO): Dogs running FEO are not eligible to receive titles. FEO results will not be included in the posted ORT results. If space remains after all qualified entries are accommodated on 8/7/23,then we will offer spaces for those who wish to run a dog (FEO). Dogs may only run FEO in odors that they are *not* already registered for.

Trial Eligibility and ORTs

The ORT Title must be earned at least 14 days before a trial opening date to be eligible for the first draw period. All odors must be passed in order to earn the ORT title. It is not required that they all be passed at the same test.

Basic Description of the Test

To successfully pass an ORT a dog must identify the location of the target odor and the handler must correctly call an "alert" within a three-minute time period. The Odor Recognition Test consists of a drill type exercise which requires 12 closed boxes typically set up in a pattern of two rows, spaced a minimum of 48" apart. The ORT is conducted on leash. Complete information can be obtained on the NACSW website. Handlers may test on all 3 odors at the same test.

All exhibitors should obtain and review a copy of the **NACSW K9 NOSE WORK® RULE BOOK.** You may get it from their website: <u>www.NACSW.net</u>

No dog will be given more than one space in the same odor test at a single event.

Results

During the odor re-sets, the official results sheet will be brought out to the parking area for testers to photo or review. We recommend you verify your results on the official results sheet and let your host or judge know if you have any questions regarding your results.

CANCELLATION POLICY

The following cancellation policy applies

For cancellation of entries on or before 8pm eastern time August 7, 2023 – Full refund minus \$5 processing fee. For cancellation of entries after 8 pm August 7, 2023 no refund will be given unless your spot can be filled and will still be minus \$5 processing fee.

Entry fees shall not be refunded if a dog or handler is absent, disqualified, or excused by the NACSW official or judge.

This cancellation and refund policy applies to competitors that must withdraw for any reason including but not limited to injury, illness, emergency, and personal or work-related reasons.

If the ORT cannot take place or be completed by reason of fire, civil disturbances, an Act of God, public emergency, or any other cause beyond the control of the test organizers, then the ORT host will make their best effort to provide partial refunds after recouping their expenses.

LOCATION DETAILS

Modeled after real-life detection work, NACSW trials are held in many different locations, with a variety of terrain, under varying weather conditions. Dogs and handlers need to be able to safely negotiate a variety of surfaces, including, but not limited to, tile, linoleum, carpeting, gravel, asphalt, uneven surfaces, and slippery footing.

Handlers should be prepared to deal with a variety of weather conditions, including heat, cold, rain and snow. Trials frequently require covering extensive distances to get to and from the parking area to each of the search areas and generally require that this be done across natural, uneven surfaces. Handlers should be prepared for the physical demands and must be able to navigate the terrain with their dog accordingly. Participants should expect to spend most of the day outside or in their vehicles as there are rarely indoor crating options at trials. Please be prepared for you and your canine partner to deal with all of these varying environmental challenges. Handlers should familiarize themselves with potential regional risks and health concerns that may affect themselves or their dogs. Handlers agree that they are entering this trial at their own risk.

ADA Site Specific Conditions

This location offers a paved parking lot for non reactive parking with closer parking upon advanced request. Due to unforeseen conditions, such as weather or change in availability of areas at the location, these conditions may be modified at the last minute.

Parking

The parking lot is paved with no shade available. It is a tight parking lot with options to park on the street. Due to unforeseen conditions, such as weather or change in availability of areas at the location, this policy may be modified at the last minute.

Reactive Dog Parking

There will be reactive dog parking on the street.

Due to unforeseen conditions, such as weather or change in availability of areas at the location, this policy may be modified at the last minute.

Unentered Dogs

We are unable to accommodate any unentered dogs at this location.

RV Parking

There is NO RV Parking available at this location.

Due to unforeseen conditions, such as weather or change in availability of areas at the location, this policy may be modified at the last minute.

Running Vehicles or Generators in the parking lot

The parking is tight at this location and running your vehicles or generators in the parking lot is allowed and parking arrangements allowed to separate those who will have their vehicle running verse not.

DOG INFORMATION

Dog Policies

- All dogs must be on a 6' leash at all times when not being tested. NO flexi-leashes while not participating in a test.
- Reactive and/or spatially challenged dogs should wear a red bandana (to be provided by the dog's handler) to help signal others that the dog needs extra space from other dogs.

- Dogs will be toileted in designated areas and handlers must pick-up and dispose of waste.
- Dogs and handlers must stay in designated areas to avoid contaminating testing space, interrupting a test, or from viewing any part of the testing.
- Competitors should expect to keep their dogs confined in a crate or vehicle when not testing and should plan to provide their own shade using canopies or shade cloths.
- Refer to location details (above) for information on unentered dogs.

Females in Season

Will be allowed to run wearing "pants" at the very end of the day after all other dogs have tested. Females in season will be parked and pottied in areas separate from the other dogs while at the test if the location logistics permit. Handlers must contact Paula Nowak at paula@caninecountryacademy.com so plans can be made for the dog.

OTHER INFORMATION

Event attendees are required to adhere to the NACSW <u>COVID-19 Event Guidelines and Rules</u> In addition to those guidelines the following changes and guidelines are in effect for this ORT due to COVID-19.

If there are any changes or updates that information will be included in your "final details" information that will be emailed 1-2 weeks before the ORT weekend. Participants are responsible for staying up to date on any jurisdictional requirements for their home location as well as the test location including any travel guidance.

Spectators

Spectating allowed with no group gathering limits: Space permitting, spectating will be allowed per ORT guidelines as outlined in the rule book. The ORT Certifying Official has the right to limit spectators at their discretion. ORT participants may have a friend or family member video/photograph their test. ORT participants may not video/photograph one another. Children under 18 must always be directly supervised by a parent/guardian. No dogs will be allowed in the spectator area. No unentered dogs with spectators are allowed at the test. Spectators are reminded that the hide placements must not be discussed nor should they speak with any participants about what they saw until after the test is complete.

An adult accompanying a minor must be present during the searches.

Everyone at the test site must sign the waiver provided by the host and comply with all event requirements. Participants are not allowed to watch the testing at any time.
