Two trials, run each day sequentially.

The run order of classes will be:

**FRIDAY:** Crazy 8 Trial 1, Crazy 8 Trial 2, Master Trial 1, and Master Trial 2 - Trial begins at 8:30 am.

*The run order for specific classes will be posted approximately at 2:30 pm on Friday.*

**SATURDAY & SUNDAY:** Instinct, Novice 1, Novice 2, Open 1, Open 2, Senior 1, Senior 2, Master 1, Master 2 - Trial begins at 8:30 am.

*The run order for specific classes will be posted at approximately 7:30 am daily.*

Day of Show entries accepted on Friday from 2:00 pm to 2:30 pm and Saturday & Sunday 7:00 am to 7:30 am each day, if limits are not reached with pre-entries. Check-in begins at 2 pm on Friday, and check-in on Saturday & Sunday begins at 7:00 am with General Briefing at 8:00 am, Judge's Class Briefing at 8:15 am for Instinct, Novice. No class briefing for Open, Senior, Master, and Crazy8s, unless there is a specific hazard or other issue to point out. A base-level map will be posted so that competitors can see the tunnel

and any Master distance challenge elements. First dog in the ring at 3 pm on Friday and Saturday & Sunday at 8:30 am

Entry fees: Instinct \$16 – Novice \$26 – Open \$28 – Senior \$30 – Master \$33 – CZ8 \$30  
Late or Day of Show entry fees: Instinct \$18 – Novice \$28 – Open \$30 – Senior \$32 – Master \$35 – CZ8 \$32

The Judge is limited to 8 hours of judging time and a maximum run value, which will require the Club to limit entries accordingly

Entries will be accepted in the order received. Please be sure your entry has all blanks filled in, is signed, and includes payment (check, money order, or cash). Incomplete and/or unsigned entries will delay processing and may be returned. PRE-ENTRIES must be RECEIVED by the TS by Friday, September 11, 2026. Maximum of 10 dog entries per envelope. Late entries must be RECEIVED by Friday, September 18, 2026. Late and/or Day of Show entries are not guaranteed entry and will be accepted only up to Judging Limits. Please note that confirmations may not be sent for late entries. Confirmations are usually sent within 48 hours of receipt (please check your spam). **PLEASE NOTE, there is no RV parking available at this trial.**

### **GENERAL INFORMATION AND POLICIES**

It is the responsibility of each competitor to read and understand the current Barn Hunt Association, LLC (BHA) Rules before participating in this event. Rules can be found at <http://www.barnhunt.com>. Signing your entry form indicates that you have read the rules.

Possessing or training with personal tubes and/or live rats is NOT permitted on the event grounds at any time.

**Barn Hunt Grounds:** Barn Hunt rules apply to any activities held at Canine Country Academy. There will be a potty area that is designated for BHA competitors, and they must pick up after their dogs on the trial grounds and at hotels and dispose of waste in appropriate containers -- BHA competitors are subject to BHA rules in these areas as well.

**Facility Info:** The gate will be open during the trial from 2:00 pm to 7 pm on Friday and 7:00 am to 5:30 pm on Saturday and Sunday.

**Blinds:** Ring will have a 10x20 indoor area of Canine Country Academy's small brick building. Instinct, Novice, Open, Senior, and Crazy8s blind will have 5 dogs. Master blind will have 4 dogs. Blind will be located at least 15', but no more than 40' from the ring.

**Leashes and collars:** See BHA Competitor Rulebook for specific information on what is allowed. Flexi-Leads are not allowed on event grounds.

**Dog aggression:** Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the event if justification is found by the judge and/or Event Committee. Entry fees will not be refunded.

**Potty Accidents in the Ring:** A fee of \$5 per incident in the barn payable by cash or Venmo.

**Bitches in season:** Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class. They must wear panties at all times (including in the ring) while not being pottied. They must be pottied in a designated area away from the other dogs. Entry fees for bitches that come into season will be refunded until the closing date of Friday, September 18th, if you wish to withdraw. **The trial secretary must be notified of BIS prior to or immediately upon arrival. Failure to do so will result in a disqualification and dismissal from the event.**

**Videotaping and photography:** Is allowed and encouraged!

**Volunteers & Worker Bucks:** Are appreciated and needed! We reward volunteering. If you have “barn bucks” from our club, you can use them by contacting our secretary to get credit added to your Secreterrier account before the trial opens. Then you’ll need to mail or turn those barn bucks in to our secretary.

**Sportsmanship:** All competitors/handlers and spectators are expected to follow the rules of the BHA and demonstrate good sportsmanship. Please do not discuss hide placement or any details of a dog’s performance that may provide information or clues to other handlers or may be overheard. Please be cognizant of teams competing in the ring and avoid loud or disruptive distractions.

**Crating:** Dogs must be leashed or crated when not actively working, and never tied out/left attached to anything other than a human. Crating space available grounds (indoor and climate-controlled) or in vehicles. Dogs must be under supervision by the owner at all times.

**Awards:** Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. Ribbons will be awarded for first through fourth place in Novice through Master. Title ribbons will also be provided. Special Awards may also be provided.

**Payment and entry information:** Entries will NOT be accepted without signatures and payment. Owners are responsible for entry errors. Please write clearly and proofread your entry. Accepted methods of payment are Venmo, check, money order, or PayPal. Incomplete forms and returned checks are invalid entries. There is a \$30.00 fee for all returned checks. Entries accepted on a first come/first served basis. Refunds are ONLY allowed if requested before the closing date of Friday, September 18, 2026. All refunds for all online entries will be less any non-refundable credit card/processor fees. After that date, no refunds will be processed. No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, sick, excused, or barred from competition by action of the Event Committee.

Canine Country Academy, and its agents, volunteers, etc., will assume no responsibilities for any loss, damage, or injury sustained by participants or spectators, or to any of their dogs or property, and further assumes no responsibility for injury to children. Canine Country Academy reserves the right to decline entries for cause and may remove any dog on account of dog or human aggression. No one shall have any recourse or claim against Canine Country Academy or any agent thereof.

### Certification of Agreement upon Registration or Entry of Dog

I certify that I am the actual owner of the dog(s), or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of the **Barn Hunt Association, LLC and Canine Country Academy** (The Clubs) in effect at the time of this event, and by any additional rules and regulations appearing in the flyer/premium for this event, and further agree to be bound by the liability waiver.
